### Rink use causing damage

While many community members (and others) are making good, safe use of our rink and skating path, there have also been some unfortunate consequences.

The rink team, following the required COVID-19 health restrictions, has tried to make it clear that hockey games were not allowed on the ice, and had removed the nets to reduce the temptation to play. However, in late January several large holes appeared in the sides of the rink, caused by too-strong hockey shots of pucks against the boards. The league faces a large bill to replace these boards.

Some other leagues have responded to unsafe or improper use of their rinks by closing the ice entirely. McKernan does not want to be forced to do this. We ask that all rink users respect the restrictions on the ice, and treat the facilities and other users with care and consideration so that everyone can continue to enjoy the rinks.

# Urban coyote research seeks volunteers

The Edmonton Urban Coyote Project at the University of Alberta is looking for volunteers in McKernan to participate in a project to increase wariness in coyotes that occupy residential neighbourhoods. Like many central neighbourhoods adjacent to natural areas, McKernan has high reported numbers of coyote sightings and interactions. Urban coyotes are increasingly common across North America, and Edmonton has a large population of the animals.

The project will examine community-based aversive conditioning of urban coyotes. Volunteers will be randomly assigned to treatment or control procedures, and must sign a U of A volunteer liability release. Precautions around COVID exposure must be followed along with the procedures for observing and treating coyotes, recording data, and maintaining safety.

The project's website notes that the end goal is "not to remove coyotes from the city, but to reduce their comfort near people and prevent them from denning in residential neighbourhoods, like underneath houses and (near schools)." Denning in residential areas can increase conflicts between humans and coyotes.

More information is available at urbancoyoteinterventionprogram.weebly.com. Anyone who enjoys getting outside in the neighbourhood can find valuable information at this site about urban coyotes. For example, coyotes will almost always run away from approaching humans – but if they don't, they can usually be scared off with sharply-opened umbrella.

The Urban Coyote Intervention Program is operated under the Edmonton Urban Coyote Project, which is led by Colleen Cassady St. Clair, professor of Biological Sciences at the University of Alberta; M.Sc. student Gabrielle Lajeunesse coordinates the program. The City of Edmonton is aware of the project and is supportive of its goals.

In other coyote news, Edmonton City Council is pondering a bylaw that would prohibit wildlife feeding on private and public property. An initial draft of the bylaw was sent back by council's community and public services committee at the beginning of February after several residents raised concerns about whether it was focussing on the most problematic behaviour. Councillor Ben Henderson noted that the focus should be on clamping down on deliberate feeding of wildlife that creates a risk to public safety.

# **SURVEY: Charles Simmonds Park upgrade**

Charles Simmonds Park (located west of 115 street and north of 78 avenue) is frequently thought to be part of Belgravia. It is actually one of the largest open-green spaces in McKernan, nestled at the edge of what is known as the McKernan Hip, sharing borders with Belgravia. In addition to serving the McKernan community, the park also serves the northern Belgravia community.

Since June of 2020, a group of homeowners surrounding the park have been exploring opportunities to upgrade the space. Recently a committee was formed, in partnership with McKernan Community League and the City of Edmonton, to start planning the project.

As laid out by the City's Neighbourhood Park Development Program, the project will go through five stages: 1) Strategy, 2) Concept, 3) Design, 4) Build and 5) Operate. Our committee has been given the go ahead to start work on stage one, which includes developing a plan to engage the community. After completion of the Strategy stage, we will move into the Concept stage, which will include working with a City project manager and landscape architect on a concept plan with more design specifics. Each stage of the process will include community engagement, feedback and input.


