LRT station apartment proposal may expand to two buildings

The development company Pinto Properties has revised its initial proposal for a car-free apartment building at 78 Ave. and 114 St. (directly beside the LRT shared use path) from one building to two, according to a meeting with the developer held in November.

The initial proposal was described in the October issue of the McKernan Messenger. The revised proposal includes:

- Two separate four-storey buildings, one at 11416-78 Ave and the second across the street at 11419-78 Ave, each with 54 bachelor or one bedroom units, including four ground floor units with direct outdoor access to the LRT shared use path. The units would be rented.
- An expanded lot for each apartment building, incorporating green space from the City.
- A new north-south alley connecting 78 Avenue to the rear lanes, with ten surface parking stalls accessed from these connecting lanes.
- Removing the existing paved turnaround and replacing it with a park.
- · Indoor bicycle parking.
- An indoor ground floor amenity room and a rooftop patio.

Pinto has told the community that they believe their proposal meets the overarching McKernan-Belgravia Station Area Redevelopment Plan. They plan to apply to the City for a zoning change to a DC2 zoning, which will be written specifically for these two sites and planned buildings. As of mid-December, they have not yet made their detailed application.

Comment on Garneau bikes and parkland

There is still time to comment on the Garneau Neighbourhood Renewal Options and Trade-offs materials presented at the open house held November 30.

McKernan residents may be interested in two parts of the plan:

1. The 110 Street Bike Lane, especially the segment from University Avenue to 76 Avenue.

Options presented at the open house for this segment were:

Option 1: On-street Protected Bike Facility — designed with NO on-street parking and with trees retained

Option 2: On-street Protected Bike Facility — designed with SOME on-street parking and with some trees removed

Option 3: Raised Bike Facility — designed with NO on-street parking and with trees retained Option 4: Raised Bike Facility — designed with SOME on-street parking and with some trees removed

Option 5: Shared-use Path - designed to retain on-street parking retained and with some trees removed

The option of leaving the road as-is (with cyclists integrated with other traffic along a quiet residential street) was not presented but could still be suggested.

Depending on which option is selected, residents along 110 St. will be impacted, while cyclists will have a more visible connection from 76 Ave north eventually to Saskatchewan Drive.

2. Improvements to Braithwaite Park (north of University Ave from 112-114 St.) that include tree-lined boulevard along 82 Avenue at the curve; relocation of the memorial plaza to reduce safety concerns; mew pathways following current pedestrian travel patterns; sidewalk upgrade along 82 Avenue at the curve (west end). Along with these improvements, there is an option for a fenced dog park area in the centre of the area, or an option to leave the space mainly open.

Full maps and details about the full Garneau Neighbourhood Renewal, including these aspects, are available at edmonton.ca/BuildingGarneau. Comments on the plan can be submitted at that site until December 21, 2019.

At this point a number of key issues have been identified, including:

- · Proposed density and number of units.
- Lack of family sized units.
- Width of the green corridor.
- Emergency vehicle access due to the removed turnaround and changed lane connections.
- Additional traffic in the rear lanes due to the missing turnarounds and to the garbage truck needed for the new apartment building.
- Number of car parking stalls and the overall impact on on-street parking, traffic congestion, and increase to lane traffic.

As their next step, Pinto would submit formal DC2 rezoning application to the City. These will trigger further negotiations as well as a public meeting in the community. Then city administration prepares a zoning bylaw amendment for Council's consideration at a public hearing. The time frame for all these steps is likely at least three months but is often longer.

Escort agency permit raises eyebrows

A development issued for an "Escort Agency" at 11520 78 Ave. has raised some questions in McKernan and Belgravia. Ben Henderson's office was contacted to invesigate, and they have clarified that the business activity on site is expected to be administrative (arranging introductions) while the services (companionship) is expected to occur offsite. If anyone witnesses visitors coming to the house, then a complaint can be made to 311 and that would initiate an investigation.

The additional wrinkle in the situation is that this property was approved earlier this year as a legal lodging house. Further inquiries are being made.
